The Club may utilize load balancing or split judging to help with trial efficiency. Any Judge of Record at this Event may be used as a Load Balancing Judge in any ring. Exhibitors may be judged by any of the listed judges. Judge of Record and Event Official dogs may be judged prior to Event start or as the first dogs of the Event. Judges are limited to 8 hours of judging and a maximum run value, which will require this club to limit entries accordingly.

**Entry Fees Per Run** - Instinct \$15, Novice & Open \$20,  
Senior/Master/Championship & Crazy8s \$25

**Late Entries Per Run** - Instinct \$20, Novice & Open \$25,  
Senior/Master/Championship & Crazy8s \$30

Late entries are not a guaranteed entry and will be accepted only up to Judging limits. Confirmations will not be sent for Late entries.

Entries open on May 30, 2021 on a first received basis. We will continue to accept entries until limits are met or until July 19, 2021. After that date, entries will be considered late and are subject to the higher fee. Late entries must be received before 5 PM PDT on July 26, 2021 via email only. Next day entries are allowed for those that are entered in the event already.

**Schedule**

**Friday, Saturday, and Sunday**

7:00 am - 7:35 am – Measuring and COVID check-in

7:40 am – General briefing in center of arena

8:00 am – First dog on the line

Grounds close 45 minutes after last dog is judged.

Second trial of the day may start as soon as possible after the ring for that class in the prior trial is concluded.

**Run Order** – The Club reserves the right to change the run order based on entries received and shall send the judging schedule prior to the start of the trial. Dogs will be run in staged groups of no more than 5 with dogs being handled by the same person separated into different staged groups. **NOTE:** Ring 3 will be - Instinct (morning trial only), Novice, Novice, Open, Open, Senior, Senior.

**Move-ups** - Forms will be available at the score table. Previous trial move-ups must be submitted no later than 5:00 pm PDT, July 26, 2021 via email. Same day move-ups are allowed at this event and must be submitted no later 30 minutes after the last class of the first trial of the day. Next day move-ups must be submitted no later than 30 minutes after the last class of the day.

**Blinds** – 10 x 30 pop-up tents. All blinds are in the open-air arena where the rings are located. Each blind is set up for 5 teams. You may sit where you like.

**Grounds** - Argus Ranch is 20 private acres and there is very limited handicapped/wheelchair accessibility on the grounds. Barn Hunt grounds is just the Zanee Arena. Boundaries will be marked by signs.

Permission has been granted by the Barn Hunt Association, LLC for the holding of these barn hunt trials under BHA Rules and Regulations.

## Exhibitor Information

### Crating

All dogs must be on lead or crated at all times unless actively working or in designated off-leash area. Due to COVID-19, no crating will be allowed in the arena. There is plenty of close parking around the arena. Please crate out of your car.

### Collars and Leads

Electronic collars, Flexi leads, bark collars, muzzles and head halters are not allowed on Barn Hunt show grounds. Collars/harnesses which can be easily and quickly removed and replaced are strongly recommended for the ring.

### Bitches in Season

Bitches in season MAY compete at Barn Hunt Trials. They will be run at the end of each class. Bitches in season must wear pants at all times except when being pottied. If bringing a bitch in season, please inform the trial secretary prior to the start of the trial and inform all exhibitors at the judge's briefing.

### Height Divisions (at withers)

Small - Dogs 13" and under

Medium - Dogs 13.1" to 18"

Large - Dogs over 18"

### Dog Aggression

Any dog behaving in a threatening or aggressive manner towards another dog or a person may be dismissed from the trial if justification is found to do so by the judge and/or trial committee.

### Animal Safety

The safety of our dogs and rats are our primary concern. By entering these trials exhibitors acknowledge that they are familiar with the rules and regulations of this sport and that their dogs are familiar and physically able to perform all course elements.

### Rooms, RV & Camping (on site)

### Awards

Instinct: All qualifying runs will receive a flat qualifying ribbon. Novice through Masters: All qualifying runs will receive a flat qualifying ribbon. In addition, all competitors receiving a placement will receive a flat placement ribbon. If a competitor receives a new title at this trial, they will be awarded a new title rosette. In addition, the club will award High in Class Ribbons to the dog receiving the best score in the Novice A, Open A, Senior A, Master, and Championship Classes. The Club will also award High in Class Ribbon for B Classes with more than four competitors. If a competitor receives a RATCH, RATCHX or higher RATCH title at this trial, they will receive a special RATCH Ribbon.

### Refunds and Cancellation Policy

After the closing date, entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the trial committee.

Every attempt will be made to hold this event as scheduled. No event fee will be refunded if the event cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the event committee.

Abuse of any kind towards volunteers, dogs, rats, competitors, or trial committee will not be tolerated and will result in immediate dismissal from the event.

Withdrawals after the closing date due to injury of the dog will be eligible for a 75% refund of entry fees paid upon receipt of a note from a veterinarian. The note must be dated and emailed or mailed to the Trial Secretary prior to the close of the trial on Sunday afternoon.

### Returned Check

A returned check does not constitute a valid entry. There will be a \$50 fee for all returned checks.

### Smoking

There is NO SMOKING inside any arena or building on the grounds or within 25 feet of any entrance to any arena or building or propane tank. If you must smoke, please do so inside your vehicle or away from these areas. Dispose of the butts in your vehicle or trash cans. Anyone found tossing their butts on the ground will be asked to pick them up immediately.
